Consultation Phase

Notice is hereby given pursuant to Section 11(1) of the Planning and Development Act 2000 (as amended) that Roscommon County Council intends to commence its review of the existing **Roscommon County Development Plan 2014 – 2020** and to prepare a new County Development Plan for the period 2021 – 2027.

The preparation of a new development plan shall be strategic in nature for the purposes of developing objectives and policies to deliver an overall strategy for the proper planning and sustainable development of the area of the development plan and the core strategy. **Strategic Environmental Assessment (SEA)**

A Strategic Environmental Assessment will be carried out as part of the review process and the Planning Authority will prepare an environmental report of the likely significant effects on the environment of implementing the new plan, in accordance with the SEA Directive (2001/42/EC) and pursuant to the Strategic Environment Assessment Regulations 2004 as amended.

Appropriate Assessment (AA)

Pursuant to Article 6(3) of the Habitats Directive 92/43/EEC and Section 177 of the Planning and Development Act 2000 as amended, an Appropriate Assessment of the likely impacts on the Natura 2000 Network of implementing the new plan will be undertaken. **Issues Paper**

The Planning Authority intends to review the zoning of the area of the development plan for the purposes of developing objectives and policies to deliver an overall strategy for the proper planning and sustainable development of the area of the development plan and the core strategy.

Requests or proposals for the zoning of particular land for any purpose shall not be considered at this stage. (Any such submissions will be returned)
